1. CALL TO ORDER

Mayor Towtongie recognized a quorum and called the meeting to order at 1:30 pm. Councillor Michael Shouldice led the opening prayer.

4. **DELEGATIONS AND HEARINGS**

- a. Honorable Elisapee Sheutiapik, Minister of Family Services, Honorable
- b. Lorne Kusugak, Minister of Health, MLA Rankin South

Honorable Elisapee Sheutiapik spoke on her Nunavut travels, and commented on the Adult Group Home that was awarded to the Hamlet of Rankin Inlet 6 years ago that has been awarded to Shift. Family Services regrets that it was not awarded to the Hamlet of Rankin Inlet. Also spoke on Child support problems.

Minister of Health, MLA Rankin Inlet Lorne Kusugak spoke on Family Services and Birthing Centre, and that the Government is talking hiring Mid-Wives from South. He also mentioned that the new Airport terminal will be built in Rankin Inlet. Covid vaccinations will be available for Mine Workers. Isolation Hubs will be continued to be used.

Councillor Merritt – Commented on the Contract for the Adult Group Home that was awarded to Shift. Hamlet Administrator will write a press release. Unfortunately there is nothing they can do about it now.

- Smoking rates in Canada that will be discussed further. People who reside in Housing Association Houses absolutely should not be smoking inside their homes.
- And it would be good if more counselors would be added to Mental Health.

Alcohol use in the community was mentioned, also beer and wine store and bootlegging.

Councillor Makkigak – As councillors we are working for the whole community. I agree with Councillor Merritt's comments, we just cannot be put aside with our needs.

- Want to know how to deal with drugs in the north, it's going on way too much in the community.
- Asked how many Hubs there are in Winnipeg, seeing the food they provide on Facebook are not fit for consuming.

Councillor Kowmuk – Thankful that the Ministers could attend our our meeting today. The hubs need to be pushed to be located in Nunavut so the people arriving from South can be observed.

- The RCMP in Rankin Inlet is very good and caring. We should be more concerned about heavy drugs that is coming around.

MLA Kusugak – the Government is looking at more Departments, and will continue working on the two mental health people, and we are hoping to get more professionals to the Department.

- We regret that Rankin Inlet did not get the contract, council should be writing a letter about it.
- There are two Isolation Hubs in Winnipeg, the patients who are doing quarantine in the hotels have to follow the rules, if they break the rules, they have to do another round. The people send me pictures of food they serve, the cooks are doing the best they can, but the patience have to go to front desk when entering the hotel to let them know what they can and cannot eat.
- There are no room for isolation in Iqaluit, as soon as we are able, we will see the Hub opening in Iqaluit.

Councillor Shouldice -

- In our college, there are so many opportunities, Government don't have to shop for workers from south, they need to keep pouring money to our programs for training Mental Officers and Nursing Programs.
- Are the people given a choice where to isolate, either in Winnipeg, Ottawa or Iqaluit?

Councillor Merrit noted that it has been a long meeting because of the the delegations and rather than make the recreation director stay any longer he would like to move the Recreation Committee Report ahead in the agenda and deal with it now. Council agrees.

Recreation Committee Report with Recreation Director David Clark present.

- -Bingo Licences for the next 6 months have been reviewed and approved by the committee. The draw to assign slots will take place next week.
- -Skidoo race committee is working toward holding their event April 30 to May2, 2021. David is working with the committee and public works to make a much larger parking lot that will allow people to properly distance in their vehicles while remaining in or near their vehicles. The committee wants to know if it will be a "Rankin" only event or will people from other communities be allowed to participate in the races. Council has no issues with the races being open to participants from other communities as long as the Chief Public Health Officer approves the event.
- -COVID guidelines continue to restrict activities that can be held due to the restriction of 50 people for indoor gatherings and 100 people for those held outdoors. Pakalaak Tyme planning is underway but it will be very difficult given the restrictions. It wont be possible to hold indoor events but some outdoor activities such as ice sculpting in front of houses will still be able to go ahead. The events will be similar to the games at Christmas. Some events will be online or through the radio.
- -Fishing Derby. That committee is still planning for a the fishing derby and continue to fundraise.
- -The arena will close for the season on April 1, 2021. Recreation and Public Works will be building 3 rinks on Williamson Lake this year. Two will be for hockey and one will be an oval for public skating.

 - 2) Annual increase of \$1,284.00 CGS allocation was increased for 2021/22 fiscal year.
