12. MAYOR/COUNCILLOR REPORTS

Councillor Kowmuk- What happened with the third ice rink on Williamson Lake? Councillor Merritt said it was plowed but the drifting snow covered it in and the crew has been clearing roads. SAO said that it would be reopened within the next day or 2.

Councillor Rudd – The Wellness committee met and things are going well. Why doesn't the committee have a spending limit> SAO explained anything in the budget already approved is ok but most of the items are new initiative that need approval from council or need to be taken back to the SAO to make sure it is an allowable expense under multiple funding agreements.

Councillor Lindell - Some one dug a ditch in Area 6 behind 5 plex where people drive their skidoos. This is very dangerous and the person responsible needs to fill it back in before somebody gets hurt.

Councillor Merritt -

Another community volunteer recognition event for the community needs to be planned Maybe make it an annual thing.

Mayor Towtongie- There is snow piled on area 6 point and it is interfering with skidoos using the trail coming in off the land. Needs to be pushed back. Also, the crossing at Nipisar lake needs to be pushed back so skidoos can cross safely.

- -Finance. Audit is scheduled for May 25. Adine has most 3rd party reporting finalized.
- -Payroll on April 9 included payments to some of our workers that qualified for a top up while working during COVID. This was funding provided by the Government of Nunavut
- -Recreational Trails. We will be applying for funding from ED&T to continue upgrades on the Diane and other trails.
- -Public works crew are busing clearing streets to lessen flooding when temperatures warm up.
